## Welcome to Aldridge North and Walsall Wood







### Did you know?


- **History** The area now known as Coppice Wood was originally called 'Goblin's Pit Wood', and it was here that limestone was mined during the late 18th and early 19th centuries. In 1841 the population of Walsall Wood numbered 900, mainly nail makers and chain makers by trade, a home-based industry at the time, the rest being mostly boatmen and brickmakers. Brickmaking, using Etruria Marl found in plentiful supply around this area, became an important industry. At one time there were six large brickyards producing the famous Staffordshire Blue Bricks. St John's Church in Walsall Wood was constructed in 1837 at a cost of £1,200. The church, with its quadrangular tower, is in the Gothic style, whilst the parsonage house is in the Elizabethan style. The church is constructed out of blue brick with stone dressings. In 1864, the population of the settlement expanded as Walsall Wood Colliery was opened and saw the establishment of the first public services including a police station and a post office. The mine was closed in 1964 when the supply of accessible coal had been exhausted: In 2010 a memorial pithead designed by Luke Perry was erected to commemorate the historic village's mining heritage.
- **Sports & Leisure -** Walsall Wood F.C. is a football club competing in the Midland Football League 1st Division at level 10, they play their home games at their ground located at Oak Park.Walsall Wood was also home to Formula 1 team Ensign Racing from 1973 to 1980 being based opposite Castlefort Primary School. Their best result being a 4th place in the 1981 Brazilian Grand Prix.

  Oak Park Active Living Centre offers swimming pools and sports facilities with new for 2024, BOX12 studio.



#### **Aldridge North and Walsall Wood Assets Map**







 Aldridge N&WW population's level of qualifications closely resembles the borough as a whole. Slightly fewer people have no qualifications, at 23.3%, contrasted to Walsall's 26.3% (approximately 1 in 4).

#### **Claimant Count**



- Aldridge N&WW's Claimant Count (Jobseekers Allowance) is low, at 2.7 per 100 working age adults.
- This is approximately half that of Walsall's Claimant rate (5.3), and over three times lower than the highest ward (Pleck, 8.5)

- Aldridge N&WW's occupational profile resembles Walsall, but differs in some key areas: employment is higher in Professional Occupations (16.4% contrasted to Walsall's 14.9%), and there are substantially fewer employed in Elementary occupations (manual labour).
- This indicates the labour force of Aldridge N&WW is distributed more towards professional, office-focussed and non-manual occupations, than elsewhere in the borough.



## Deprivation





Whilst large areas of the ward are more deprived than the England average, overall Aldridge North and Walsall Wood is a mixed picture: areas of little deprivation alongside more moderately deprived (decile 4-5) areas. None are are highly deprived.



- Aldridge North & Walsall Wood's household population of full-time students and schoolchildren, aged over 5yrs, is 17.3%. This is below the Walsall figure (22.1%) and matches both Short Heath and Streetly wards in terms of proportion.
- Single-family households, consisting of a lone parent with dependent children, make up 6.7% of homes,ranking 7th lowest in Walsall. The number of lone parent households in Aldridge North & Walsall Wood is approximately half of those in Birchills-Leamore (769)
- Higher number of homeowners 72.1% are owned. Of those,56% are owned outright, without a mortgage or shared ownership. 12% of households rent privately or live rent free (Borough 16.5%). One in seven homes in Aldridge North & Walsall Wood are socially rented (15.1%) with a very similar number seen in Short Heath.
- The number of households living with **no** central heating across the borough has decreased since 2011. Aldridge North & Walsall Wood has the 2<sup>nd</sup> lowest proportion of households living without central heating at 0.91%, the Walsall figure is 1.61%. Aldridge North & Walsall Wood has 51 households living with no central heating, this also ranks 2<sup>nd</sup> lowest in number, just above Streetly (48) and just below Paddock (53).

#### % Households in Ward with no Central heating






# Development / Regeneration

- Well established residential areas with good access to greenbelt and open space such as Shire Oak Park.
- Local centres providing a range of good service: Walsall Wood and Streets Corner.
- The ward is home to the **Oak Park Active Living Centre** which offers a wide range of leisure and sports facilities for the local community.
- The Maybrook Industrial Estate to north of the ward is home to several manufacturing and engineering businesses, such as European Heathyards, ATSolutionsUK and Gerrymet.

- A new Lidl Supermarket is currently under construction in the south of the ward at the former Horse and Jockey Public House site on Walsall Road creating 40 new jobs.
- **Walsall Road** contains a future housing opportunity site for a potential 57 units and is allocated in the Walsall Site Allocation Document.
- Planning consent granted in 2024 for residential scheme at the former Walsall Wood Library site.
- Council works to provide continued support to businesses/landowners with regard to their development requirements and growth aspirations.





Census 2021, resident population




#### **Population Pyramid**

#### **Key Points:**

- Aldridge North and Walsall Wood has one of the oldest populations in Walsall, with around 2 in 9 people over the age of 65, and a median age of 46 years old: approximately 7 years above the Borough average (39 years), and a stark contrast to the youngest wards, Blakenall and Pleck, at 32 years.
- Aldridge North and Walsall Wood is one of only 4 x wards that have seen a decline in it's population since 2011, it is the 3rd most sparsely populated ward, equating to just 1,676 people per sq. km. For context, Walsall's borough density is 2,733, and Bentley & Darlaston North, has roughly twice as many people per sq. km (3,359).
- Ethnically, the ward is predominantly White British (91%), with small populations of Asian (4%), Black (2%), Mixed (2%) and Other (1%). The Asian, Black and Other populations have doubled since 2011, however the White group decreased by 4%.






# Language and Religion



**97%** of Households where All Adults use English as main language





- 98.8% of households have all or at least one adult where English is the main language, 2<sup>nd</sup> highest in borough in contrast to 81.1% of Palfrey households.
   When English is not the main spoken language, there are fewer (18%) residents who cannot speak English or cannot speak it well, compared with Palfrey (35%)
- Aldridge North & Walsall Wood has the second lowest proportion of Non-English speakers in households (53), equating to only 0.9% of all households in the ward, compared to only 14.2% in Pleck ward (788).

### 56% household residents are Christian (Borough 45%)


- Aldridge North ward has a majority population of Christians (56.1%). This has the third highest percentage population in Walsall's wards. It has the fourth highest number of Christians in the borough.
- 34.3% of residents reported in 2021 Census as having No Religion, higher than Walsall (30.2%) and much higher Palfrey (11.1%), Walsall's most religious ward.

#### **Key Points:**

- With 95.6% of residents being UK born, Aldridge North and Walsall Wood has the 3<sup>rd</sup> largest proportion of UK born residents of the 20 Walsall wards.
- Approximately 4.4% of Aldridge North and Walsall Wood's population originates from non-UK nations, relatively less than the borough's 14.7%.
- The largest area of non-UK birth is the Middle East and Asia, at around 182 residents or approximately 1.4% of the ward's population (Borough 8%). This is followed by EU14 born residents: founding EU states such as Germany, France, Italy and Spain, accounting for 0.8% of the ward's population (106 residents).
- It suggests that the non-UK born communities of Aldridge North and Walsall Wood are relatively smaller than typical of the Walsall borough.


#### Social Segment Composition of Aldridge North & Walsall Wood (% Households)





The overall GLD for Walsall in 2022 was 59%. 68% of children resident in the Aldridge North and Walsall Wood ward achieved a GLD, better than the LA and National figures. Aldridge North & Walsall Wood are ranked 6th highest achieving compared to other wards in Walsall.

Achieving GCSE English and maths in 2022





#### **Key Points:**

Attainment data by ward is matched based on children resident in the ward who attended any Walsall school within the local authority. Any children who attended an out of borough school are excluded from the analysis.

Pupils take national curriculum assessments in year 6 at the end of KS2, when most will reach the age of 11. Pupils take tests commonly referred to as SATs. A higher proportion of children who reside in the Aldridge North and Walsall Wood ward achieve the expected standard when compared to the Walsall and National averages particularly in maths.

At the end of KS4 (Year 11) pupils sit examinations in a range of GCSE and other vocational qualifications.


The percentage of pupils in Walsall who have achieved at least a grade 4 or above in English and maths GCSE is slightly below national at 63%. Students resident in the Aldridge North and Walsall Wood ward do better with 65% achieving a standard pass at GCSE.

More students who live in the ward achieve a good pass in English and maths GCSE than locally - 5% higher than the Walsall LA figure and 2% higher than the National average.





- Aldridge North and Walsall Wood residents report their general level of health favourable, with 78.7% reporting good health or better this is approximately average for Walsall Wards, but below the England average (82.1%).
- At 6.1% of the population, just over 1 in 16 residents reported living in poor health or worse.

- A further 6.6% have a long term physical or mental Health condition where daily activities are not limited.






# Child Healthy Weight



The prevalence of Reception-aged children who are overweight or obese in Aldridge North and Walsall Wood is lower than the Walsall average and has been decreasing in trend since 2018/19. However, it is still higher than the national rate.



The prevalence of Year 6 children who are overweight or obese in Aldridge North and Walsall Wood is also lower than the Walsall average, but has seen an increase in trend since 2019/20, and is significantly higher than the national rate.




